WINTER FUEL SUPPORT SCHEME

As part of support package of over £50m to address immediate pressures on living costs Welsh Government has made available over £38 million through a Winter Fuel Support Scheme.

Eligible households can claim a one-off £100 payment to provide support towards paying their on-grid winter fuel bills.

The scheme is open to households where one member is in receipt of working age meanstested welfare benefits (at any time between the 1 December 2021 and 31 January 2022):

- Income Support, or
- Income Based Job Seekers Allowance, or
- Income Related Employment & Support Allowance, or
- Universal Credit, or
- Working Tax Credits.

The payment will be available to all **eligible households** regardless of whether they pay for their on-grid fuel on a pre-payment meter, by direct debit or by paying a bill quarterly.
